In exercise of the powers conferred by 1st proviso to section 14 of the Right to Fair Compensation and Transparency in land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013), the Government of Kerala hereby extend the time limit in publishing the Notification as per sub-section (1) of Section 11 of LARR Act, 2013, from the date of appraisal of the Social Impact Assessment report by the Expert Group namely:-

G.O(P) 289/2022/RD dated 18.11.2022 and published in the Extraordinary Gazette No. 3894 dated 18th November, 2022 has been issued in accordance with the provisions as per sub section (1) of section 4 of the Right to Fair Compensation and Transparency in land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013) with regard to the acquisition of land in Cheruvanur & Panniyankara Villages of Kozhikode district for the construction of Areekad Flyover in Ramanattukara – Vattakinar road.

AND WHEREAS, the District Collector, Kozhikode has informed that as per section 14 of LARR Act, 2013 where a preliminary notification under sub-section (1) of section 11 is not issued within twelve months from the date of appraisal of the Social Impact Assessment report submitted by the Expert Group under section 7, then, such report shall be deemed to have lapsed and a fresh Social Impact Assessment shall be required to be undertaken prior to acquisition proceedings under section 11. The date of appraisal of the Social Impact Assessment report by the Expert Group under section 7 was submitted on 28.04.2023 and as such the Notification under sub-section (1) of section 11 needs to be issued on or before 28.04.2024.

AND WHEREAS, the District Collector, Kozhikode has requested to extend the time limit in publishing the Notification as per sub-section (1) of Section 11 of LARR Act, 2013 from the date of appraisal of the Social Impact Assessment report by the Expert Group.

NOW THEREFORE, sanction is accorded to extend the time limit for a further period of 6 months from the date of expiry ie. 28.04.2024 in publishing the Notification under sub-section (1) of section 11 by invoking the provisions contained in 1st proviso to section 14 of LARR Act, 2013 with regard to the acquisition of land in Cheruvanur & Panniyankara Villages of Kozhikode district for the construction of Areekad Flyover in Ramanattukara – Vattakinar road.

Explanatory Note

G.O(P) 289/2022/RD dated 18.11.2022 and published in the Extraordinary Gazette No. 3894 dated 18th November, 2022 has been issued in accordance with the provisions of subsection (1) of section 4 of the Right to Fair Compensation and Transparency in land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013) with regard to the acquisition of land in Cheruvanur & Panniyankara Villages of Kozhikode district for the construction of Areekad Flyover in Ramanattukara - Vattakinar road. As per section 14 of LARR Act, 2013 where a preliminary notification under subsection (1) of section 11 is not issued within twelve months from the date of appraisal of the Social Impact Assessment report submitted by the Expert Group under section 7, then, such report shall be deemed to have lapsed and a fresh Social Impact Assessment shall be required to be undertaken prior to acquisition proceedings under section 11. The date of appraisal of the Social Impact Assessment report by the Expert Group under section 7 was submitted on 28.04.2023 and the Notification as per sub-section (1) of section 11 needs to be issued on or before 28.04.2024. 1st proviso to section 14 of LARR Act, 2013 specifies that Govt. shall have the power to extend the period of twelve months, if in its opinion circumstances exist justifying the same and hereby extend the time limit for a further period of 6 months from the date of expiry ie. 28.04.2024 in publishing the Notification under sub-section (1) of section 11.

The notification is intended to achieve the above object.
