WHEREAS, it appears to the Government of Kerala that the land specified in the Schedule below is needed or likely to be needed for a public purpose, to wit for the acquisition of 2.90 Hectares of land in various villages of Thrissur district for the Improvements to Nadathara - Moorkanikara - Kannara road.

AND WHEREAS, in exercise of the powers conferred in sub-section (1) of section 4 of the Right to Fair Compensation and Transparency in land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013), Government of Kerala have decided to conduct a Social Impact Assessment in the area specified in the schedule below.



NOW THEREFORE, sanction is hereby accorded to Social Impact Assessment Unit, viz. Centre for Socio Economic & Environment Studies (CSES), Khadi Federation Building, NH Bypass, Padivattom, Kochi to conduct a Social Impact assessment Study and to prepare a Social Impact Assessment Plan as provided in the Act. The process shall be completed within a period of 3 months in any case.

The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Rules has come into force on 19.09.2015 and as per Rule 10 notifying a Social Impact Assessment Unit for conducting Social Impact Assessment Study is required.
