In exercise of the powers conferred by 1st proviso to Section 25 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013), the Government of Kerala hereby extend the time limit in publishing the Award as per Section 25 to the Declaration issued under subsection (1) of Section 19 as per Proceedings No. DCTSR/1456/2019/E4 dated 04th April 2023 and published in the Extra Ordinary Gazette No. 1270 dated 04th April 2023 namely:-

As per Proceedings No. DCTSR/1456/2019/E4 dated 04th April 2023 and published in the Extra Ordinary Gazette No. 1270 dated 04th April 2023, the Declaration in accordance with the provisions of subsection (1) of Section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 with regard to the acquisition of 0.2788 hectare of land in Kanimangalam Village of Thrissur Taluk in Thrissur district for the construction of Nedupuzha ROB has been issued.

AND WHEREAS, the District Collector, Thrissur has reported that as per Section 25 of LARR Act, 2013 mentions that the Collector shall make an Award within a period of 12 months from the date of issuance of 19(1) Declaration ie, the 19(1) Declaration issued as per Proceedings No. Proceedings No. DCTSR/1456/2019/E4 dated 04th April 2023 and published in the Extra Ordinary Gazette No. 1270 dated 04th April 2023 expired on 04.04.2024 and therefore requested to extend the time limit in publishing the Award.

NOW THEREFORE, sanction is accorded to extend the time limit in publishing the Award for a further period of twelve months from the date of expiry of the 19(1) Declaration ie 04.04.2024 by invoking the provisions contained in 1st proviso to Section 25 of the LARR Act, 2013 with regard to the acquisition of 0.2788 hectare of land in Kanimangalam Village of Thrissur Taluk in Thrissur district for the construction of Nedupuzha ROB, as the last chance on the condition that no more extension be granted under any circumstances.
