Sub: FCSD – Appointment of Members of State Food Commission – reg

The vacancies of the Members of State Food Commission under National Food Security Act, 2013 are proposed to be filled by nomination from a panel prepared by the Selection committee appointed by the State Government. The details regarding the qualification, experience etc is as follows;

a) Name of Post	Member,

b) No. of Post	Four
c) Scale of pay	The salaries and allowances of Members of the State Food Commission shall be as determined by the Government from time to time:
	If the member is a retired Government servant, his/her pay has to be fixed as per rule 100 Part III of Kerala Service Rules.

d) Place of posting	Thiruvananthapuram
e) Age limit & Tenure	5 years or 65 years. (No Person shall hold office for a term not exceeding 5 years and after attained the age of 65 years)
f) Method of Recruitment	By nomination from a panel prepared by the Selection committee appointed by the State Government. (As envisaged in Chapter IV of the Kerala Food Security Rules, 2018 published as per SRO No.356/2018 (GO(P)No.5/2018/FCSD))
	a) who are/have been member of the All India Services or any other civil services of the Union or State or holding a civil post under the Union or State having knowledge and experience in matters relating to food security, policy making and administration in the field of agriculture, civil supplies, nutrition, health or any allied field; or
g) Eligibility	b)one who has eminence in public life with wide knowledge and experience in Agriculture, Law, Human Rights, Social Service, Management, Nutrition, Health, Food policy or public Administration; or

- c) who have a proven record of work relating to the improvement of the food and nutrition rights of the poor.
- 2. Selection shall be subject to the general condition that, in State Food Commission including Chairperson, Member Secretary & Members, there should be two women, one Scheduled Caste member and one Scheduled Tribe member in the Commission as envisaged in Section 16(2) of the NFS Act, 2013.
- 3. It is requested that the applications of the suitable and willing candidates with biodata may kindly be sent to the Secretary, Food & Civil Supplies Department, Govt. Secretariat, Kerala or e-mail to secy.food@kerala.gov.in within a period of 15 days from the date of publication of this notification.
