## Sub: Inviting application for the post of Chief Investigation Officer in State Police Complaints Authority.

Applications are invited by the Government for filling up the post of Chief Investigation Officer in the State Police Complaints Authority in line with the G.O.(Rt)No.691/2022/Home dated 15.03.2022. The term of appointment will be for a period of two years. The person appointed will not be eligible for regularization.

Mode of Recruitment : Direct (on contract basis) Remuneration : Rs.75,000/-pm (consolidated)

#### **Job Description :-**

Investigate custodial violence including all types of physical and mental torture inflicted upon a person in police custody by a police personnel. Draft investigation plan for early identification of issues by assessing the scope and determining the methodology and techniques required to carry out a thorough and effective investigation. Obtain facts or statements from complainants, witnesses and accused persons, record interviews using recording device. Monitor conditions of victims who are unconscious so that arrangements can be made to take statements if consciousness is regained. Organize scene search, analyze data, Station House GD, technical information, medical, postmortem report, inquest report to determine what additional information and investigative work are needed. Record progress of investigation, maintain data informational files on suspects safely, submit timely reports to Chairperson, SPCA. Liaison with officers of police department in connection with investigation of all complaints. Maintain surveillance to obtain information on suspects. The position requires regular travel depending on investigational requirements. All other duties related to investigations are as required.

#### **Qualifications :**

#### General: :-

a) The candidate should be a person of ability, integrity, and should have adequate knowledge and have shown capacity in the field of investigation.

b) The candidate should be prepared for hard work as the job involves field work in remote areas, hilly terrains and with adequate knowledge and capacity in the field of human rights protections, criminal justice and crime investigation.

c) Should be well versed in the decisions of the Hon'ble Supreme Court and High Courts on custodial torture, human right violation, illegal arrest and detention etc.

#### **Educational Qualification - Essential :-**

a). Candidate should possess Post Graduate degree in any Social Science subject preferably Human Right or Human rights Law or Sociology from any of the universities incorporated by an Act of the Central or State Legislature in India or other educational institutions established by an Act of Parliament or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956.

#### **Educational Qualification- Desirable :-**

a). A degree in Law recognized by the Bar Council of India for the purpose of enrollment as an Advocate.

b). Graduate degree or Diploma or any other certified course in Criminology/ Psychology/ Crime Detection/ Criminal Justice process which is not less than one year from any of the universities incorporated by an Act of the Central or State Legislature in India or other Educational Institutions established by an Act of Parliament or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956.

#### **Experience - Essential :-**

a). Should have worked in the rank of Deputy Superintendent of Police in Central / State Investigation Agencies like CBI, NIA, RAW, Intelligence Bureau, SHRC, NHRC etc on regular basis in the scale of pay for a minimum period of 3 years and not worked in Kerala Police and have sufficient experience in investigation / Inquiry related to Crime detection or custodial violations or Human Rights violations etc.

b). Candidate should be well versed in crime data analyzing / Human

Right Protection / Criminology / Psychology / Crime detection.

c). Should have good knowledge and communication skill in English, Hindi and proficiency in Malayalam language.

d). Should have excellent hands-on experience with computer including advanced software, advanced applications, advanced mobile phones, Internet and MS-Office system.

#### **Experience - Desirable :-**

a). Senior level experience in the field of Criminal Law, analyzing information, Crime data, information gathering, Office Management, investigation or intelligence, thorough knowledge in Criminal Justice processes, National Security, Enforcement etc.

b). Experience or acquaintance with organization involved in Police reforms considered as additional experience.

#### Age Limit :-

Shall not complete 62 years of age on the last date of submitting the application as prescribed in the notification

#### Mode of submitting application:-
