G.O(P) No.5/2026/F&P

S. R. O. No. 390/2026

WHEREAS, under sub-section (1) of section 33 of the Kerala Co-operative Societies Act, 1969 (21 of 1969), the term of an administrator or an administrative committee appointed to manage the affairs of a society shall not exceed one year in the aggregate;

AND WHEREAS, the said term of one year of the administrator appointed under sub-



section (1) of section 33 of the said Act to manage the affairs of the Vellayani Kayal Fishermen Development Welfare Co-operative Society Limited No. F(T)314 in Thiruvananthapuram District expired on 2nd February, 2026.

AND WHEREAS, under sub-section (1A) of section 33 of the said Act, the Government may, by notification in the Gazette, for reasons to be recorded, permit the Registrar of Co-operative Societies (Fisheries) to extend the term of said administrator or administrative committee for a further period not exceeding one year in the aggregate or till a newly elected committee enters upon office, whichever is earlier;

AND WHEREAS, the Joint Director of Fisheries who is also the Registrar of Co-operative Societies (Fisheries) has reported that election to the Board of Directors of the said society could not be conducted with the extended period due to numerous complaints were received alleging that the previous managing committee of the society had granted new memberships irregularly, an investigation is currently in progress. Due to this situation, it was not possible to conduct the managing committee election on time. Further, following the issuance of the notification for the 2025 Local Self-Government Institutions elections, the Government issued an order vide G.O.(P) No. 158/2025/Co-op dated 13<sup>th</sup> November, 2025, stating that the election procedures of societies in which elections were scheduled to be held between 10<sup>th</sup> November, 2025 and 7<sup>th</sup> February, 2026 may be conducted after 7<sup>th</sup> February, 2026 and has requested to permit him to extend the term of the administrator for a further period of one year from 3<sup>rd</sup> February, 2026 to 2<sup>nd</sup> February, 2027 or till a newly elected committee enters upon office, whichever is earlier, to avoid administrative vacuum in the said society.

AND WHEREAS, the Government have considered the matter in detail and are satisfied that it is necessary, in public interest, to permit the Director of Fisheries, who is also the Registrar of Co-operative Societies (Fisheries) to extend the term of the administrator appointed to manage the affairs of the said society for a further period of one year from 3<sup>rd</sup>, 2026 to 2<sup>nd</sup> February, 2027 or till a newly elected committee enters upon office, whichever is earlier, to avoid administrative vacuum in the said society;

NOW, THEREFORE, in exercise of the powers conferred by Sub-Section (1A) of Section 33 of the Kerala Co-operative Societies Act, 1969 (21 of 1969), the Government of Kerala hereby permit the Director of Fisheries, who is also the Registrar of Co-operative Societies (Fisheries) to extend the term of the administrator or administrative committee appointed to manage the affairs of the Vellayani Kayal Fishermen Development Welfare Co-operative Society Limited No. F(T)314 in Thiruvananthapuram District for a further period of one year from 3<sup>rd</sup> February, 2026 to 2<sup>nd</sup> February, 2027, or till a newly elected committee enters upon office, whichever is earlier, to avoid the administrative vacuum in the said society.

### **Explanatory Note**

(This does not form part of the order, but is intended to indicate its general purport.)

The term of the administrator appointed under sub-section (1) of section 33 of the Kerala Co-operative Societies Act, 1969 (21 of 1969), to manage the affairs of the Vellayani Kayal



Fishermen Development Welfare Co-operative Society Limited No. F(T)314 in Thiruvananthapuram District expired on 2<sup>nd</sup> February, 2026. The Director of Fisheries who is also the Registrar of Co-operative Societies (Fisheries) has requested to permit him to extend the term of the administrative committee for a further period of one year from 3<sup>rd</sup> February, 2026 to 2<sup>nd</sup> February, 2027 or till a newly elected committee enters upon office, whichever is earlier. The Government have considered the matter in detail and are satisfied that it is necessary, in public interest, to permit the Director of Fisheries who is also the Registrar of Co-operative Societies (Fisheries) to extend the term of the administrator appointed to manage the affairs of the said society for a further period of one year from 3<sup>rd</sup> February, 2026 to 2<sup>nd</sup> February, 2027 or till a newly elected committee enters upon office, whichever is earlier to avoid administrative vacuum in the said society.

The Notification is intended to achieve the above object.
