No.1090/2023 in the Kerala Gazette Extraordinary No. 3350 dated 12<sup>th</sup> October, 2023, to hold

enquiries and to advise the Government in the matter of revision of minimum rates of wages payable to the employees employed in the Private Hospital sector in the State of Kerala, for a further period upto 31st December, 2024

## **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

The term of office of the committee appointed as per notification issued under G.O.(P) No.86/2023/LBR. dated 11<sup>th</sup> October, 2023 and published as S.R.O. No.1090/2023 in the Kerala Gazette Extraordinary No. 3350 dated 12<sup>th</sup> October, 2023, to hold enquiries and to advise the Government in the matter of revision of minimum rates of wages payable to the employees employed in the Private Hospital sector in the State of Kerala expired on 11<sup>th</sup> April, 2024. Now, the Government have decided to extend the term of office of the said committee for a further period upto 31<sup>st</sup> December, 2024 with effect from 12<sup>th</sup> April, 2024 to enable the said committee to complete its work.

The notification is intended to achieve the above object.
