The following draft rules further to amend the Kerala Motor Vehicles Rules, 1989, which the Government of Kerala propose to make in exercise of the powers conferred by sub-section (6) of section 41 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), is hereby published for general information as required by sub-section(1) of section 212 of the said Act.

Notice is hereby given that the said draft rules will be taken up for consideration on or after thirty days from the date of publication of this notification in the Gazette and that objections or suggestions, if any, that may be received from any person in respect of the said draft rules on or before



the date specified above, will be considered by Government. Objections or suggestions, if any, in duplicate shall be addressed to the Additional Chief Secretary to Government, Transport Department, Government Secretariat, Thiruvananthapuram.

DRAFT RULES

- 1. Short title and commencement.- (1) These rules may be called the Kerala Motor Vehicles (...... Amendment) Rules, 2023.
 - (2) It shall come into force at once.
- 2. Amendment of the rules.- In the Kerala Motor Vehicles Rules, 1989,
 - (i) in rule 91, for the last para, the following para shall be substituted, namely:-

"The Regional Transport Officer (Nationalised Sector)-I shall be the Registering Authority in respect of the vehicles owned by State Transport Undertakings and the Regional Transport Officer (Nationalised Sector)-II shall be the Registering Authority in respect of the vehicles owned by the Central Government, State Government, Local Self Government Departments, Public Sector Undertakings, Quasi Government Institutions, Autonomous bodies, Boards and Corporations:

Provided that the Regional Transport Officer (Nationalised Sector)-I shall act as the Registering Authority of Regional Transport Office (Nationalised Sector)-II as well".

- (ii) in rule 92,
 - (a) after sub-rule (1), the following provisos shall be inserted, namely:-

"Provided that the Group of letters and Registration code of vehicles owned by State Transport Undertakings other than motor cars and jeeps owned by such undertakings shall be KL 15;

Provided further that the Group of letters and Registration code of vehicles owned by or on behalf of State Government shall be KL 90 followed by the alphabet A and series of numbers, Central Government shall be KL 90 followed by the alphabet B and series of numbers, Local Self Government Departments shall be KL 90 followed by the alphabet C and series of numbers and vehicles owned by Quasi Government Institutions, Autonomous bodies, Boards, Corporations and vehicles owned by State Transport Undertakings other than those under purview of the above proviso shall be KL 90 followed by the alphabet D and series of numbers;

Provided further that the vehicles registered in the name of Government Departments, vehicles owned by Quasi Government Institutions, Autonomous bodies, Boards, Corporations and Local Self Government Departments prior to the amendment of this rule, shall be re-assigned with the Group of letters, Registration code and the series of numbers, as prescribed in rule (1) within six



months from the date of amendment of this rule. The previous registration numbers of vehicles reassigned as above shall cease to exist and shall be cancelled".

(b) in sub-rule (2), after the words "State Transport Undertaking," the following words shall be inserted, namely:-

"registered by the Regional Transport Officer (Nationalised Sector)-I, the vehicles of Central Government, State Government, Local Self Government Departments, Quasi Government Institutions, Autonomous bodies, Boards and Corporations registered by the Regional Transport Officer (Nationalised Sector)-II".
