WHEREAS, the Government of Kerala have constituted the Advisory Board, under the Kerala Anti-social Activities (Prevention) Act, 2007 (34 of 2007) with Shri Mohammad Vaseem (Retired District Judge) and Advocate P.N.Sukumaran as members of the said Advisory Board as per notification issued under



HOME-SSA5/231/2021-HOME dated 17th February, 2022 and published as S.R.O. No.153/2022 in the Kerala Gazette Extraordinary No.549 dated 17th February, 2022;

AND WHEREAS, the tenure of appointment of the members of the said Advisory Board will expire on 16th February, 2025;

AND WHEREAS, the Government have decided to re-appoint Shri Mohammad Vaseem (Retired District Judge) and Advocate P.N.Sukumaran as the members of the said Advisory Board;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 8 of the Kerala Anti-Social Activities (Prevention) Act, 2007 (34 of 2007), the Government of Kerala hereby re-appoint Shri Mohammad Vaseem (Retired District Judge), 1F, Jains Charing Cross, Kaloor -Kadavanthara Road, Kathrikadavu Junction, Ernakulam – 682017 and Advocate P.N.Sukumaran, Puliammakil House, South Paravoor P.O., Manakunnam Village, Ernakulam-682307 as the members of the Advisory Board constituted under Kerala Anti-Social Activities (Prevention) Act, 2007, (34 of 2007) for a period of three years with effect from 17th February, 2025.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per notification issued under HOME-SSA5/231/2021-HOME dated 17th February, 2022 and published as S.R.O. No.153/2022 in the Kerala Gazette Extraordinary No.549 dated 17th February, 2022, the tenure of appointment of



the members of the Advisory Board constituted under Kerala Anti-social Activities (Prevention) Act, 2007 (34 of 2007) expires on 16th February, 2025. Now the Government have decided to re-appoint Shri Mohammad Vaseem (Retired District Judge) and Advocate P.N.Sukumaran as members of the said Advisory Board for a period of three years with effect from 17th February, 2025.

The notification is intended to achieve the above object.
