In exercise of the powers conferred by 1st proviso to Section 25 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013), the Government of Kerala hereby extend the time limit in publishing the Award as per Section 25 to the Notification issued as per sub-section (1) of section 19 issued as per Proceedings No. 104791/2016 dated 03rd March, 2023 and published in the Extra Ordinary Gazette No. 819 dated 06th March, 2023 namely:

As per Proceedings No. 104791/2016 dated 03rd March, 2023 and published in the Extra Ordinary Gazette No. 819 dated 06th March, 2023, the Declaration in accordance with the provisions of sub-section (1) of section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 with regard to the acquisition of 1.4850 Hectares of land in Balaramapuram & Athiyanoor Villages for the widening of road from Balaramapuram to Vazhimukku (left side) as part of development of Karamana - Kaliyikavila road has been issued.

AND WHEREAS, the District Collector, Thiruvananthapuram has reported that as per Section 25 of LARR Act, 2013 mentions that the Collector shall make an Award within a period of 12 months from the date of issuance of 19(1) Declaration and the 19(1) Declaration issued as per Proceedings No. 104791/2016 dated 03rd March, 2023 and published in the Extra Ordinary Gazette No. 819 dated 06th March, 2023 will expire on 05.03.2024 and therefore requested to extend the time limit in publishing the Award.

NOW THEREFORE, sanction is accorded to extend the time limit in publishing the Award for a further period of 6 months from the date of expiry of the 19(1) Declaration ie. 05.03.2024 by invoking the provisions contained in 1st proviso to Section 25 of the LARR Act, 2013 with regard to the acquisition of 1.4850 Hectares of land in Balaramapuram & Athiyanoor Villages for the widening of road from Balaramapuram to Vazhimukku (left side) as part of development of Karamana - Kaliyikavila road.
