Under clause (1) of Article 243-I of the Constitution of India and section 186 of the Kerala Panchayat Raj Act, 1994 (13 of 1994), read with clause (1) of Article 243-Y of the Constitution of India and section 205 of the Kerala Municipality Act,1994 (20 of 1994), the Governor of Kerala is now pleased to extend the term of the Finance Commission constituted as per notification issued under G. O. (P) No.146/2019/Fin. dated 31st October, 2019 and published as S. R. O. No. 796/2019 in the Kerala Gazette Extraordinary No. 2618 dated 31st October, 2019 and extended up to 31st January, 2022 as per notification issued under G. O. (P) No. 150/2021/Fin. dated 16th November, 2021 and published as S. R. O. No. 848/2021

in the Kerala Gazette Extraordinary No. 3409 dated 17th November, 2021 for a further period of two months from 1st February, 2022 to 31st March, 2022 and consequently make the following further amendment to the said notification, namely:—

In the notification issued as S. R. O. No. 796/2019, in paragraph 2, for the words and figures "upto 31st January, 2022", the words and figures "up to 31st March, 2022" shall be substituted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The term of the Finance Commission was fixed for two years from the date of the notification issued under G. O. (P) No. 146/2019/Fin. dated 31st October, 2019 and published as S. R. O. No. 796/2019 in the Kerala Gazette Extraordinary No. 2618 dated 31st October, 2019 and extended up to 31st January, 2022 as per notification issued under G. O. (P) No. 150/2021/Fin. dated 16th November, 2021 and published as S. R. O. No. 848/2021 in the Kerala Gazette Extraordinary No. 3409 dated 17th November, 2021. As such the period of the Finance Commission had expired on 31st January, 2022. The Commission has recommended the extension of its term. Accordingly, the Governor of Kerala has been pleased to extend the term of the Finance Commission from 1st February, 2022 to 31st March, 2022.

The notification is intended to achieve the above object.
