In exercise of the powers conferred under sub-sections (1) and (2) of section 27 of the Juvenile Justice (Care and Protection of Children) Act, 2015 (Central Act 2 of 2016), read with rule 15 of the Juvenile Justice (Care and Protection of Children) Model Rules, 2016, the Government of Kerala hereby make the following amendment to the notification issued under G.O.(P) No.8/2022/WCDD dated 16th June, 2022 and published as S.R.O No.619/2022 in the Kerala Gazette Extraordinary No.2063 dated 22nd June, 2022, namely:-

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Government of Kerala have reconstituted the Child Welfare Committee for fourteen Districts in the State of Kerala as per notification issued under G.O.(P) No.8/2022/WCDD dated 16th June, 2022 and published as S.R.O. No.619/2022 in the Kerala Gazette Extraordinary No.2063 dated 22nd June, 2022. In the said notification in respect of serial No.II, Child Welfare Committee for Kollam District, Sri.Alan M. Alexander, Seenay, Vishnathukavu Nagar-95, Thirumullavaram P.O., Kollam-691 012 was nominated as Member of the said Committee. Now as per judgment dated 18.02.2025 of the Hon'ble High Court of Kerala, in WA No. 1737/2024 against the judgment in WP (C) No. 21014/2022, the Hon.ble High Court quashed the appointment of Sri.Alan M. Alexander as a member of the Child Welfare Committee, Kollam, and declared that Sri.Krishnan Kutty Nair.C is eligible to be appointed as a member of the said Committee. Hence the Government have decided to nominate Sri.Krishnan Kutty Nair.C, Mangalathu Veedu, Thrikkovilvattom, Mukhathala P.O, Kollam District, who is immediately next in the waiting list (in the Select Panel for Members of the Child Welfare Committee) as Member, until the end of term of the current committee, in the Child Welfare Committee, Kollam District in the place of Sri.Alan M.Alexander.

The notification is intended to achieve the above object.
