WHEREAS, the Government of Kerala have constituted the Advisory Board, under the National Security Act, 1980 (Central Act 65 of 1980) with Mr.Justice N. Anil Kumar (Retired High Court Judge) as Chairman and Shri Mohammad



Vaseem (Retired District Judge) and Advocate P.N.Sukumaran as members as per notification No. HOME-SSA2/273/2023-HOME dated 03<sup>rd</sup> April, 2024 and published as S.R.O No.367/2024 in the Kerala Gazette Extraordinary No.1253 dated 03<sup>rd</sup> April, 2024;

AND WHEREAS, Mr. Justice N.Anil Kumar (Retired High Court Judge) resigned from the post of Chairman of the Advisory Board consequent to his appointment as the Lok Ayukta;

NOW, THEREFORE, in exercise of the powers conferred by section 9 of the National Security Act, 1980 (Central Act 65 of 1980) read with sub clause (a) of clause (4) of Article 22 of the Constitution of India, Government of Kerala hereby appoint Mr.Justice P.Ubaid (Retired High Court Judge), Lilac, Kanmani Lane/Ashoka Lane, Ashoka Road, Kaloor, Ernakulam as the Chairman of the Advisory Board, National Security Act, 1980 (Central Act 65 of 1980) and makes the following consequential amendment to the above said notification, namely:-

#### **AMENDMENT**

In the said notification, for serial number (1) and the entries against it, the following serial number and entries shall be substituted, namely:-

"(1) Hon'ble Mr. Justice P. Ubaid, (Retired High Court Judge), Lilac, Kanmani Lane/Ashoka Lane, Ashoka Road, Kaloor, Ernakulam.

#### **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

Government have constituted the Advisory Board, National Security Act,



1980 (Central Act 65 of 1980) with Mr.Justice N. Anil Kumar (Retired High Court Judge) as Chairman and Shri Mohammad Vaseem (Retired District Judge) and Advocate P. N. Sukumaran as members as per notification No. HOME-SSA2/273/2023-HOME dated 03<sup>rd</sup> April, 2024 and published as S.R.O. No.367/2024 in the Kerala Gazette Extraordinary No.1253 dated 03<sup>rd</sup> April, 2024.

Mr. Justice N.Anil Kumar (Retired High Court Judge), the Chairman of the said Advisory Board was appointed as the Lok Ayukta as per Notification No.GS5-1773/2024 dated 27<sup>th</sup> July, 2024 issued from the Kerala Raj Bhavan and he resigned from the post of Chairman of the Advisory Board, National Security Act, 1980 (Central Act 65 of 1980). Hence the Government have now decided to appoint Mr. Justice P.Ubaid (Retired High Court Judge) as Chairman of the Advisory Board, National Security Act, 1980 (Central Act 65 of 1980) and to amend the notification issued as S.R.O No. 367/2024.

The notification is intended to achieve the above object.
