In exercise of the powers conferred by 2nd proviso to subsection 7 of section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013), the Government of Kerala hereby extend the time limit in publishing the declaration as per sub-section 1 of section 19 to the Notification issued under sub-section (1) of section 11 as per G.O(P) No. 21/2021/RD dated 5th February, 2021 and published in the Extra Ordinary Gazette No 551 dated 5th February, 2021, namely:-

Notification No G.O(P) No 21/2021/RD dated 5th February, 2021 and published in the Extra Ordinary Gazette No. 551 dated 5th February 2021 has been issued in accordance with the provisions of sub-section (1) of section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 with regard to the acquisition of 202.0644 Hectares of land in Keezhalur, Paduvilayil and Ancharakandi Villages for establishing Industrial Park for KINFRA.

AND WHEREAS, the District Collector, Kannur has reported that as per Section 19(7) of LARR Act, 2013 mentions that the 19(1) Declaration has to be published within 12 months from the date of issuance of 11(1) Notification (preliminary notification) and that the 11(1) Notification issued as per G.O(P) No. 21/2021/RD dated 5th February 2021 and published in the Extra Ordinary Gazette No 551 dated 5th February 2021 and extended as per G.O.(P) No.72/2022/RD dated 21st February 2022 and published in the Extra Ordinary Gazette No 583 dated 21st February 2022, G.O(P) No. 73/2023/RD dated 06th March 2023 and published in the Extra Ordinary Gazette No. 820 dated 06th March 2023, G.O(P) No. 193/2023/RD dated 14th August 2023 and published in the Extra Ordinary Gazette No. 2695 dated 14th August 2023 and G.O(P) No. 44/2024/RD dated 06th February 2024 and published in the Extra Ordinary Gazette No. 466 dated 6th February 2024 expired on 05/08/2024 and therefore requested to extend the time limit for publishing the 19(1) Declaration.

NOW THEREFORE, sanction is accorded to extend the time limit in publishing the Declaration for a further period of six months from the date of expiry of the 11(1) notification ie. 05/08/2024 by invoking the provisions contained in 2nd proviso to Section 19(7) of the LARR Act, 2013 with regard to the acquisition of 202.0644 Hectares of land in Keezhalur, Paduvilayil and Ancharakandi Villages for establishing Industrial Park for KINFRA.
