In exercise of the powers conferred by clause (a) of sub-section (1) of section 5 read with section 9 of the Minimum Wages Act, 1948 (Central Act 11 of 1948), the Government of Kerala hereby make the following amendment to the notification issued under G.O.(P) No.20/2023/LBR. dated 4th February, 2023 and published as S.R.O. No.182/2023 in the Kerala Gazette Extraordinary No. 419 dated 4th February, 2023, namely:-



AMENDMENT

In the said notification,

(i) under the heading "I. Persons Representing Employees", for the entry against serial number 16, the following entry shall be substituted, namely:-

"Shri. Poulose K.M.,

Kadambumkuzhiyil House, Vellasseri,

Kaduthuruthy, Kottayam - 686605.".

(ii) under the heading "II. Persons Representing Employers", for the entry against serial number 2, the following entry shall be substituted, namely:-

"Shri. Jose Kavanad,

All Kerala Houseboat Brokers and Owners Association (AKHBOA), Thekkekkara P.O, Alappuzha.".

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per notification issued under G.O.(P) No.20/2023/LBR. dated 4th February, 2023 and published as S.R.O. No.182/2023 in the Kerala Gazette Extraordinary No.419 dated 4th February, 2023, the Government have appointed the Advisory Board for the purpose of co-ordinating the work of the committees and sub-committees appointed under section 5 of the Minimum Wages Act, 1948 and for advising the Government generally in the matter of fixing and revising the minimum rates of wages in various scheduled employment sectors in the State of Kerala. Now, the Government have decided to appoint Shri. Poulose K.M., Kadambumkuzhiyil House, Vellasseri, Kaduthuruthy, Kottayam - 686605 as a person representing employees in the place of Shri. Jose Puthett, Puthett House, Venkurinji P.O., Mukoottuthara, Erumeli, Kottayam. and to make consequential amendment in the said notification. Further, the Government have also decided to make necessary changes in the address of Shri. Jose Kavanad, who is a person representing employers in the said committee.

The notification is intended to achieve the above object.
