In exercise of the powers conferred by clause (a) of sub-section (1) of section 5 of the Minimum Wages Act, 1948 (Central Act 11 of 1948), read with rule 3 of the Kerala Minimum Wages Rules, 1958, the Government of Kerala, hereby extend the term of the three sub-committees appointed as per notification issued under G.O.(P) No. 40/2023/LBR. dated 12th April, 2023 and published as S.R.O. No. 489/2023 in the Kerala Gazette Extraordinary No. 1352 dated 17th



April, 2023, for a further period of six months with effect from 17th April, 2024.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The term of office of the three sub-committees constituted as per notification issued under G.O.(P) No.40/2023/LBR. dated 12th April, 2023 and published as S.R.O. No. 489/2023 in the Kerala Gazette Extraordinary No.1352 dated 17th April, 2023 to hold enquiries and to advise the Government in the matter of revision of minimum rates of wages payable to the employees employed in the Airport, Screen Printing, Tree Climbing, the manufacture of Gold and Silver Ornaments, Shops and Commercial Establishments including the employment in Courier Services, D.T.P. Centres, Internet Cafes, Telephone Booths, Catering Services and House Boat Service, Printing Presses, Fish Peeling, Fish Canning, Freezing and Exporting of Sea Foods, Paper Production Industry, Photography and Videography, Chartered Accountants Office, Hosiery Manufacturing, Small Plantations Industry, Drying of coconut for making Copra, the manufacture of Ayurvedic and Allopathic Medicines, Beedi and Cigar Production, Light Motor Vehicles, Hill Products Industry, Rubber Crape Mills, Sales Promotion of Pharmaceutical products, the Cane and Bamboo Industry, Agricultural Operations and allied sectors such as dairy farms, nurseries and cashew plantations, Footwear Manufacturing, Security Services, Domestic Labour and Ice Factories Sectors in the State of Kerala was expired on 16th April, 2024. The Government have, now decided to extend the term of office of the said three sub-committees for a further period of six months with effect from 17th April, 2024 to enable the said sub-committees to complete their work.

The notification is intended to achieve the above object.
