In exercise of the powers conferred by clause (a) of sub-section (1) of section 5 read with section 9 of the Minimum Wages Act, 1948 (Central Act 11 of 1948), the Government of Kerala hereby make the following amendment to the notification issued under G.O.(P) No.86/2023/LBR. dated 11<sup>th</sup> October, 2023 and published as S.R.O. No.1090/2023 in the Kerala Gazette Extraordinary No. 3350 dated 12<sup>th</sup> October, 2023, namely:-

### **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

As per notification issued under G.O.(P) No.86/2023/LBR. dated 11<sup>th</sup> October, 2023 and published as S.R.O. No.1090/2023 in the Kerala Gazette Extraordinary No. 3350 dated 12<sup>th</sup> October, 2023, Government constituted a Committee to hold enquiries and advise the Government in respect of revision of minimum rates of wages payable to the employees employed in the Private Hospital sector in the State of Kerala. Now, the Government have decided to appoint Shri. Shoby Joseph, Puthanpurakkal (H), Pulickathotty P.O., Vannappuram, Vanchikkal, Idukki - 685607, as an Employee Representative in the place of Smt. Reshmi Parameswaran, State Secretary, Kerala State United Nurses Association, Reg.
