ORDINANCE No. 141 OF 2021

THE KERALA PUBLIC SERVICE COMMISSION (ADDITIONAL FUNCTIONS AS RESPECTS CERTAIN CORPORATIONS AND COMPANIES) AMENDMENT ORDINANCE, 2021

Promulgated by the Governor of Kerala in the Seventy-second Year of the Republic of India.

AN

ORDINANCE

further to amend the Kerala Public Service Commission (Additional Functions as respects certain Corporations and Companies) Act, 1970.

Preamble.—WHEREAS, the Kerala Public Service Commission (Additional Functions as respects certain Corporations and Companies) Amendment Ordinance, 2021 (138 of 2021) was promulgated by the Governor of Kerala on the 13th day of September, 2021;

AND WHEREAS, a Bill to replace the said Ordinance by an Act of the State Legislature could not be introduced in, and passed by, the Legislative Assembly of the State of Kerala, during its session which commenced on the 4th day of October, 2021 and ended on the 11th day of November, 2021;

AND WHEREAS, under sub-clause (a) of clause (2) of Article 213 of the Constitution of India the said Ordinance will cease to operate on the 15th day of November, 2021;

AND WHEREAS, difficulties will arise if the provisions of the said Ordinance are not kept alive;

AND WHEREAS, the Legislative Assembly of the State of Kerala is not in session and the Governor of Kerala is satisfied that circumstances exist which render it necessary for him to take immediate action;

Now, Therefore, in exercise of the powers conferred by clause (1) of Article 213 of the Constitution of India, the Governor of Kerala is pleased to promulgate the following Ordinance:—

1. Short title and commencement.—(1) This Ordinance may be called the Kerala Public

Service Commission (Additional Functions as respects certain Corporations and Companies)

Amendment Ordinance, 2021.

(2) It shall come into force on such date as the Government may, by notification in

the Gazette, appoint.

2. Act 19 of 1970 to be temporarily amended.—During the period of operation of this

Ordinance, the Kerala Public Service Commission (Additional Functions as respects certain

Corporations and Companies) Act, 1970 (19 of 1970) (hereinafter referred to as the principal

Act) shall have effect subject to the amendment specified in section 3.

3. Amendment of section 2.—In section 2 of the principal Act, in clause (a), the words,

figures and brackets "or the Kerala Non-Resident Keralites' Welfare Board constituted under

section 9 of the Non-Resident Keralites' Welfare Act, 2008 (10 of 2009)" shall be inserted at

the end, before the symbol ";".

4. Repeal and saving.—(1) The Kerala Public Service Commission (Additional

Functions as respects certain Corporations and Companies) Amendment Ordinance, 2021

(138 of 2021) is hereby repealed.

(2) Notwithstanding such repeal, anything done or any action taken under the

principal Act, as amended by the said Ordinance, shall be deemed to have been done or taken

under the principal Act, as amended by this Ordinance.
