
DETAILS UNDER SECTION 4(1) OF RIGHT TO INFORMATION ACT 2005

- I. Sainik Welfare Department mainly deals with welfare and rehabilitation issues of Ex-servicemen, Serving Soldiers and their dependents. Welfare measures of Central Armed Police Force Personnel is also being dealt with in the department. This Department was part of the General Administration Department. An Independent Department named as Sainik Welfare Department was formed vide G.O(MS)No.272/2017/GAD dated 22.08.2017. The Rules of Business was amended accordingly vide Notification No.53/2018 dated 25.01.2018. Now the following subjects are being dealt with in the Department.
- 1. Establishment matters of Department of Sainik Welfare.
- 2. Matters relating to the welfare of serving soldiers and Exservicemen.
- 3. Matters relating to Chief Minister's Sainik Welfare Fund, Military Benevolent Fund, Amalgamated Fund and Flag Day Fund.
- 4. Matters relating to the Civil Military Liaison Conference.
- 5. Grant of cash awards to the recipients of Gallantry and Non-Gallantry Awards.
- 6. Matters relating to employment assistance to the dependents of defence personnel killed/disabled/missing in operational

engagements or circumstances similar to operational engagements.

- 7. Welfare measures of the Para Military Forces of the Union.

IV. The following are the major schemes that are administered through Department of Sainik Welfare.

- 1. Employment Assistance to the Dependents of Military and Central Armed Police Force Personnel.
- 2. Grant of Cash Awards to the recipients of Gallantry and Non-Gallantry decorations of Military Service.
- 3. Monthly Financial Assistance to the Second World War Veterans and widows
- 4. One time Scholarship to the Cadets who got admission to various training academies under Armed Forces.
- 5.Grant of Cash Award to the recipients of Territorial Army Decorations/Medals
- 6. Bright Student Scholarship to the wards of Ex-servicemen studying from 10th to Post Graduate Classes
- 7. Rehabilitation Training to Ex-servicemen and their dependents.
- 8. Assistance from Chief Minister's Defence Forces/CAPF/GREF Personnel's Welfare Fund.

In addition to the funds provided in the budget for Rehabilitation and Welfare of the Ex-servicemen and their Dependents, there are several schemes which are implemented utilizing the following funds.

- 1. SMBF/DMBF administered by Rajya Sainik Board headed by the Chief Minister- 28 Schemes
- 2. Amalgamated fund administered by State Managing Committee headed by Hon'ble Governor of Kerala.
- 3. Schemes financed by Kendriya Sainik Board.
