Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Section 3 of the Kerala State Right to Service Act, 2012 (18 of 2012) empowers, every Department of the Government, Heads of Department, Local Self Government Institutions and Statutory Bodies to notify in the Gazette, the services that will be rendered by each of them, along with details of stipulated time limit, Designated Officers, First Appellate Authority and the Second Appellate Authority. The Government have decided to notify the services to be rendered by the Government in the General Administration (FFP-A) Department and the Officers in respect of such service as stipulated in the said section.

The notification is intended to achieve the said purpose.
