S. R. O. No. 883/2012.--In exercise of the powers conferred by section 3 of the Kerala State Right to Service Act, 2012 (18 of 2012), the Chairperson of the Scrutiny Committee for verification of Community Certificates hereby notify the services mentioned in the Schedule below to be the services that will be rendered by the said committee constituted under section 8 of the Kerala (Scheduled Castes and Scheduled Tribes) Regulation of Issue of Community Certificates Act, 1996 (Act 11 of 1996) and also notify the Designated Officer, the First Appellate Authority, the Second Appellate Authority and the stipulated time limit, in respect of such services, namely:--

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Section 3 of the Kerala State Right to Service Act, 2012 (18 of 2012), empowers, every Department of the Government, Heads of Departments, Local Self Government Institutions and Statutory Bodies to notify in the Gazette, the services that will be rendered by each of them, along with details of the stipulated time limit, Designated Officers, First Appellate Authority and the Second Appellate Authority. The Government have decided to notify the services to be rendered by the Scrutiny Committee constituted under section 8 of the Kerala (Scheduled Castes and Scheduled Tribes) Regulation of Issue of Community Certificates Act, 1996 (Act 11 of 1996) and the officers in respect of such services as stipulated in the said section.

The notification is intended to achieve the said purpose.
